RESOLUTION S-2021-12A  
SCHEDULE OF FEES & CHARGES FOR 2022**

**BE IT RESOLVED** and it is hereby resolved by the Hollidaysburg Sewer Authority, Blair County, Pennsylvania, that the Hollidaysburg Sewer Authority Schedule of Fees and Charges for 2022 are approved as follows:

<b>Establish Account</b>	\$ 10.00
<b>Tapping Fee</b>	\$ 1,200.00 per household or Equivalent Dwelling Unit
<b>Connection Fee</b>	\$ Actual cost of labor and materials incurred to install the sewer service lateral from the Hollidaysburg Sewer Authority main to the curb line of the customer property or easement, including any permitting costs, administrative costs, and excavation restoration costs. A Connection Fee Deposit is required at the time of application submission per the following schedule.

**Connection Fee Deposit\***

Standard Service Line (Up to 6")	\$ 1,350.00
Greater than 6" Service Lines	\$ Amount to be estimated at time of application

\*A Connection Fee Deposit shall be paid at time of application for the connection to cover the anticipated cost of the Connection Fee. The deposit shall be based on the size of the connection requested. Upon completion of installation of the connection and determination of actual cost of the connection from the Authority main to the curb line, any overpayment will be refunded to applicant. If the actual cost is determined to exceed the Connection Fee Deposit amount, the difference will be billed to the applicant and must be paid before the service is activated.

<b>Customer Facilities Fee</b>	\$ Actual cost of labor and materials incurred to install any facilities, including metering devices, serving the connected property from the curb line of the property into the customer residence or building.



Diluted Wastewater (Holding Tank Waste)	\$75.00/1000 gal + \$10.00 /Load service fee + direct cost of any necessary lab analysis
