ORDINANCE NO. 896

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF HOLLIDAYSBURG, BLAIR COUNTY, PENNSYLVANIA AMENDING PARTS 2 AND 4 OF CHAPTER 15 OF THE HOLLIDAYSBURG BOROUGH CODE OF ORDINANCES WITH RESPECT TO STOP INTERSECTIONS AND PARKING REGULATIONS

WHEREAS, an engineering and traffic study was completed by the Hollidaysburg Chief of Police as permitted by PENNDOT Publication 212.4 finding stop signs were warranted at certain intersections as detailed in his report dated July 2, 2019; and

WHEREAS, a review of certain parking conditions in the Gaysport area of Hollidaysburg by the Borough Manager with a citizen of Gaysport was undertaken and presented to Council; and

WHEREAS, a business that utilized a loading/unloading zone on Montgomery Street has closed with no existing business having returned to the location for a substantial length of time negating the need for such loading/unloading zone.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COUNCIL OF THE BOROUGH OF HOLLIDAYSBURG AS FOLLOWS:

Section 1. Chapter 15, Part 2, Section 214 (1) (D) is hereby amended by the **addition** of the following streets:

D. All Way Stop Intersections.

Stop Street

Intersection or Through Street

Wayne Street

Pine Street

Mattern Orchard Drive

McIntosh Lane

Mattern Orchard Drive

Baldwin Lane

Section 2. Chapter 15, Part 4, Section 403 is hereby amended to **delete** the following streets so as to permit parking:

§403. Parking Prohibited at All Times in Certain Locations.

Parking shall be prohibited at all times in the following locations:

Street

Side

Between

Betts Street

North

Newry Street and Good Lane

Section 3. Chapter 15, Part 4, Section 403 is hereby amended by the **addition** of the following streets to prohibit parking:

§403. Parking Prohibited at All Times in Certain Locations.

Parking shall be prohibited at all times in the following locations:

Street

Side

Between

Betts Street

South

Franklin Street and Newry Street

Section 4. Chapter 15, Part 4, Section 403 is hereby amended with respect to the southern side of Beaver Street between Jackson Street and Lowe Street and the southern side of Betts Street between Newry Street and Jackson Street to modify the portion of the streets where parking is prohibited as follows:

§403. Parking Prohibited at All Times in Certain Locations.

Parking shall be prohibited at all times in the following locations:

StreetSideBetweenBeaver StreetSouthBow Alley and Lowe StreetBetts StreetSouthGood Lane and Jackson Street

Section 5. Chapter 15, Part 4, Section 408 (4) is deleted to remove the restricted loading and unloading zone at 306-1/2 through 312 Montgomery Street (two spaces).

Section 6. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinances. It is hereby declared as the intent of the Council of the Borough that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

Section 7. Except as set forth herein, no other amendment is made to Chapter 15 or any prior amendments to Chapter 15, and the existing provisions un-amended hereby shall remain in full force and effect. All other ordinances or parts of ordinances that are inconsistent herewith are hereby repealed.

Section 8. This Ordinance shall become effective upon the earliest date provided by law.
