BOROUGH COUNCIL MEETING MINUTES THURSDAY, FEBRUARY 11, 2021 7:00 PM TELECONFERENCE MEETING/COUNCIL CHAMBERS

CALL TO ORDER: This meeting was called to order at 7:00 PM by Vice President Sean Burke.

PRESENT: A quorum was present including members of Council as follows: Joseph A. Pompa; James Mielnik; Sean Burke; Brady Leahey; Richard Scholton; and Joyce Lowe. Also participating: Borough Manager Jim Gehret; Mayor Joseph Dodson; Borough Secretary Patricia J. Duron; Attorney Jeff Murceak; Building Code Official Gerald Harbison; and Chief Rodney B. Estep. Michele Baker was absent.

PLEDGE OF ALLEGIANCE: Vice President Burke led the pledge of allegiance and a moment of silence.

MINUTES: The minutes from the January 14th meeting were presented for Council's approval. A motion to approve these minutes was made by Mr. Scholton and was seconded by Mr. Leahey. A vote was taken and the minutes were approved, six votes to zero votes.

MANAGER'S REPORT & MONTHLY FINANCIAL REPORT: Mr. Gehret advised that his manager's report was in the agenda binder. There will be no monthly financials until April.

PLANNING AND ZONING REPORT: Mr. Harbison reported that he hopes to be moving forward with the comprehensive plan update in March.

MAYOR'S REPORT: The Mayor reported on the procedure for renewals of the mechanical licenses within the Borough. He requested that the 2021 fees be waived.

PUBLIC COMMENT:

Regis Nale, 210 Jackson Street: Mr. Nale spoke with in favor of an appointment to the Zoning Hearing Board.

OPEN AGENDA: The Mayor requested that discussion regarding the mechanical licenses fees for 2021 be waived to be added to the March 11th agenda.

RESOLUTION NO. 2021-2, CONSENT AGENDA: Mr. Gehret asked for Council's consideration of Resolution No. 2021-2 for bill list number 2 totaling \$212,862.19 and three Certificates of Appropriateness. A motion was made by Mr. Pompa and was seconded by Mrs. Lowe to approve Resolution No. 2021-1. A vote was taken with the motion carrying, six votes to zero votes.

DISCUSSION: UPDATE ON VIDEO CONFERENCING: Mr. Gehret updated council about video conferencing in Council Chambers for future meetings. DANGEROUS STRUCTURE INVESTIGATION 215 - 217 BLAIR STREET: Mr. Harbison advised Council about the Borough Engineer's report on the condition of the structure at 215 – 217 Blair Street. A motion was made by Mr. Leahey that a show cause hearing be scheduled. Mr. Mielnik seconded the motion and a vote was taken. The motion passed unanimously, six votes to zero votes.

RESOLUTION NO. 2021-3 TO SUPPORT THE JUNIATA WATERSHED MANAGEMENT PLAN UPDATE: A motion was made by Mr. Pompa and was seconded by Mr. Leahey to approve this resolution. A vote was taken and the motion passed in vote of six votes in favor to zero votes against.

RESOLUTION NO. 2021-4 APPROVING THE CORONAVIRUS RELIEF FUND GOVERNMENTAL RECIPIENT AGREEMENT: Mr. Scholton made a motion to approve Resolution No. 2021-4. Mrs. Lowe seconded the motion and all voted in favor. The motion passed, six votes in favor to zero votes against.

APPOINTMENT OF DANIELLE FITCH TO THE ZONING HEARING BOARD: A motion was made by Mr. Leahey to appoint Danielle Fitch to the Zoning Hearing Board. Mr. Mielnik seconded this motion. A vote was taken and the motion was approved, six votes in favor to zero votes against.

ADJOURN: Vice President Burke announced at 7:24 PM that they would have an executive session regarding personnel issues and would not return to the meeting.
